Eligibility: All participants must be current USATT or ITTF affiliate members. Unrated entrants will have their initial rating estimated for seeding purposes by the tournament committee. If you have recently purchased a membership but have not received a membership card, you must show proof that you have renewed.

Friday evening practice: The room will be open for setup and **practice from 7:00pm-9:55pm Friday.**

Check In: The facility will open at 8:30am on Saturday. All players **MUST** check in at the control desk **prior to 9:00am** to **guarantee** their participation. Walk-in is ok if spots are available. If there are people waiting to play, and you fail to check in 9:00 am your spot will be replaced and you will receive a full refund. If there is no one to replace you, you will not receive your refund.

Play typically begins between 9:00am-9:15am on Saturday and concludes by 6pm

Entry Deadline: Wednesday October 17th 2012.

Refunds granted for those canceling before the deadline. If the tournament is cancelled all money will be refunded including the USATT fee if desired.

Format: The October 2012 tournament will be two rounds. Both rounds are round-robin format. Scores will be recorded and results sent to USATT for each match. Each of the six table will have from 4-6 players depending on the number of attendees.

Round One will disperse the top six players by rating and seed. Each table group 4-6 players in descending rating will be assigned to tables by computer generated spread with attention to Club affiliation and variety.

Round Two will group all players finishing 1st, all players finishing 2nd, etc. Seriatim will be established by won/loss record in matches. Two way ties will be broken by head-to-head results; multiple-way ties will be broken by the tournament committee using in order: matches won/lost ratio, games won/lost ratio, points won/lost ratio, rating differentials or by lot between the tied players.

Equipment: Only USATT approved equipment will be allowed. Stiga Expert Roller tables, nets and 40 mm white or orange Nittaku or DHS Premium 3 Star balls will be provided for play. The floor is wood.

Clothing: The USATT dress code will govern.

Rules: A match will be 3 out of 5 games, 11 points. All USATT regulations apply. Decisions of the tournament committee are final. Play will be on assigned tables only. Warm-up play is limited to 2 minutes.

Second Round Awards: **Cash prizes** Group A 1st \$200. 2nd \$100. 3rd \$50. Table Groups B through F each table winner will receive \$20 and a trophy.

Schedule: Round One **Start-9am.** Round Two **Start- about 1pm.** We will finish before 5pm each day.
